On November 13, 2023, at approximately 0745 hours. Driver 1 who's name is being withheld pending notification of next of kin, was driving a brown 1995 Toyota Tacoma at a high rate of speed eastbound on Albion Ridge Road, east of Middle Ridge Road in Albion, Ca. For unknown reasons the driver allowed the truck to veer off the east shoulder. Subsequently, the vehicle began to overturn off the roadway. The driver was not wearing a seatbelt and was ejected from the vehicle. Emergency personnel arrived on scene and the driver was pronounced deceased. There were no witnesses to the crash. The cause of the crash and the sobriety of the driver are still under investigation.
