AT SR-222 (TALMAGE ROAD). PARTY#2 (HALE) WAS DRIVING HIS CADILLAC ESCALADE WESTBOUND ON TALMAGE ROAD AT AN ESTIMATED 35-40 MPH, EAST OF SANFORD RANCH ROAD. PARTY #1 FAILED TO STOP AT THE INTERSECTION AND CONTINUED FROM SANFORD RANCH ROAD INTO THE WESTBOUND LANE OF SR-222 (TALMAGE ROAD). PARTY #2 ATTEMPTED TO STOP HIS VEHICLE AND VEER TO THE LEFT BUT HE WAS UNABLE TO AVOID THE CRASH AND THE FRONT PASSENGER PORTION OF HIS VEHICLE STRUCK PARTY #1. AFTER THE CRASH HALE REMAINED ON SCENE AND CONTACTED EMERGENCY SERVICES TO REPORT THE CRASH. UKIAH VALLEY FIRE AUTHORITY TRANSPORTED THE FEMALE RIDER TO THE UKIAH AIRPORT WHERE REACH AIR AMBULANCE SERVICES TRANSPORTED PROCTOR TO SANTA ROSA MEMORIAL HOSPITAL FOR MEDICAL TREATMENT. THE CALIFORNIA HIGHWAY PATROL IS INVESTIGATING THIS CRASH. ALCOHOL AND OR DRUGS ARE NOT CONSIDERED TO BE A FACTOR IN THIS CRASH.
