Public Notice: The National Weather Service has issued an Excessive Heat Warning beginning 11 AM Tuesday, July 2nd through 8 PM Saturday, July 6 2024.

On July 1, 2024 Public Health issued an Excessive Heat Advisory to the Ukiah and Redwood Valley areas, where high temperatures are forecast to exceed 110 degrees with limited overnight relief with lows near 70, although the rest of the county will also experience extreme heat away from the coast. This Advisory will expire with the National Weather Service Excessive Heat Warning.

High temperatures increase the risk of dehydration and other heat related illnesses. Please be especially mindful of those who have limited mobility or are susceptible to the heat, including children and older adults. It is suggested that individuals attempt to reduce exertion, stay in a cool place when possible and drink plenty of water to stay hydrated.
