and came to rest on it's roof. The driver sustained fatal injuries and was pronounced deceased at the scene by medical personnel.											
The name of the deceased is being withheld until notification to family members can be made. Alcohol or drug use does not appear to be a factor in the crash This crash remains under investigation by the Ukiah CHP.
